Communication with the BCS Parent Community continues to be an ongoing issue. BCS admin prefers to communicate via Email and Social Media. Volunteer requests and School Council information is rarely responded to, as most parents have indicated they do not open or read electronic communications or follow Social Media for updates. Paper correspondence is discouraged, and Agenda messages are not communicated (Elementary). Jr./Sr. High students do not use Agenda's. Written communication can be included in the Newsletter, but it is often published later in the month, and Parents have indicated they do not always read it in it's entirety. This makes it problematic to discuss options for ASCE Grant and provide feedback for the Workbook discussions, as attendance for SC Meetings is dismal.

Parents have requested different options for Fun Lunches (Hot Dog Day, Hamburger Day, Treat Day - Texas Donuts), but additional options have been discouraged due to approved Nutritional Guidelines (other than what the School arranges with local businesses - Extreme Pita and Cafe Plus Pizza).

The Parent Community has communicated it is frustrated with limited/infrequent Field Trip Options to support/enhance Learning Objectives.
